WHO'S INVOLVED IN THIS PROJECT

The **COMMONS** is a project supported by the City of Washington and the Daviess County Economic Development Foundation, with generous support from the Washington Knights of Columbus, the Regional Opportunity Initiatives, Inc., and the Lilly Endowment GIFT VII Program.



WHAT IS INCLUDED IN THE COMMONS?

The **COMMONS** includes a variety of new amenities, including a large, multi-purpose event pavilion, a performance pavilion and gathering lawn and a market pavilion that will serve as a host to a variety of downtown events. Additional amenities include bench swings, passive gathering areas and potential public art and spray fountain.



WHAT IS THE COST OF THE PROJECT?

Based on the current design input and program elements included as part of the **COMMONS**, the current construction cost estimate is \$3.1 million, but additional funds are needed.

WHEN IS CONSTRUCTION ANTICIPATED?

The **COMMONS** formally began construction in the Spring of 2023.

WHO WILL OWN THE COMMONS?

The **COMMONS** is a public project that will be maintained by the City of Washington.



HOW WILL THE PARK BE MAINTAINED?

As part of the **OUR COMMON HERITAGE CAMPAIGN**, it is anticipated that a permanent endowment for facility maintenance will be established with Our Community Foundation, Inc., which wil include future funds from the Common Heritage Campaign.

OUR COMMON HERITAGE - PARTICIPANT INFORMATION

The Commons of Daviess is transforming empty lots in downtown Washington into a vibrant and community-centered gathering space along historic Main Street in the heart of downtown. The conceptual design provides a space that can be used for community-wide events and programming. There will be a variety of spaces within the park, including areas for community gatherings, reflection and social activities.

The **OUR COMMON HERITAGE CAMPAIGN** is an opportunity to participate in ensuring that this signature public space celebrates and honors our community. Four levels of support are available as part of this campaign. 


OVERVIEW


OVERVIEW

View of the Commons Heritage Wall, which includes sponsor participation identification and interpretive storytelling elements.


OVERVIEW
